



Lampert Simnel





Perkin Warbeck





Maria Theresa of Austria





Maria Theresa's claim to the French throne was never recognized. However, she did succeed in securing the Austrian throne for her son, Joseph II.

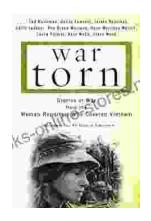

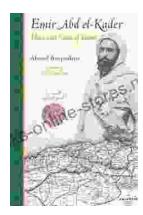
